Tier 1: Discovery Consultation

Fee: £195 (online) | £275 (in person)

Purpose: For families exploring options or unsure where to start.

- Pre-meeting review of key documents (e.g. EHCP, reports)
- 75-minute consultation (Zoom or in person)
- Verbal recommendations of suitable school types and next steps
- Follow-up summary email outlining options and actions
- Turnaround: 5 working days from meeting

Tier 2: School Shortlist & Placement Plan

Fee: £850

Purpose: For families seeking tailored school recommendations and a clear admissions roadmap.

- All services from Tier 1
- Full review of EHCP and professional reports
- Research and written shortlist of 4–6 recommended schools
- Comparison of provision and suitability summary
- Admissions timeline and placement action plan
- Email support for 2 weeks
- Turnaround: 10–14 working days



Tier 3: Placement Support & School Liaison

Fee: £1,950

Purpose: For families who want hands-on support through the application process.

- All services from Tiers 1 & 2
- Direct liaison with shortlisted schools
- Drafting or reviewing application forms and statements
- Preparation for interviews/visits
- Attendance (in person or virtual) at one school visit or review meeting
- Ongoing advisory support for up to 6 weeks
- Turnaround: within the academic term of engagement

Tier 4: Premium SEN Placement Pathway

Fee: £3,500 – £4,500 (depending on complexity)

Purpose: Comprehensive end-to-end support for families navigating complex SEN placement decisions.

- All services from Tiers 1–3
- Coordination with professionals (EP, SALT, OT)
- Advocacy and representation in placement or EHCP review meetings
- Preparation of written parental representations or supporting statements for LA
- Attendance at up to 3 meetings (school, LA, or tribunal prep)
- Priority access and phone support throughout
- Typical duration: 2–3 months full support
